



**Proclamation  
Child Abuse Awareness and Prevention Month  
April 2026**

**WHEREAS**, in Federal fiscal year 2025, the Texas Department of Family & Protective Services confirmed 289,854 victims of child abuse or neglect, including 25 in Llano County; and

**WHEREAS**, Hill Country Children's Advocacy Center interviewed 126 Llano County children for abuse in 2025; and

**WHEREAS**, currently there are 13 open court cases involving 19 Llano County children as of this day; and

**WHEREAS**, child abuse and neglect are a serious problem affecting every segment of our community, and finding solutions requires input and action from everyone in our community; and

**WHEREAS**, our children are our most valuable resources and will shape the future of Texas; and

**WHEREAS**, child abuse can have long-term psychological, emotional, and physical effects that can have lifelong consequences for victims, their families; and

**WHEREAS**, the impact of abuse and neglect has long-term personal, economic and social costs; therefore, hurting Texas' future; and

**WHEREAS**, protective factors are conditions that reduce or eliminate risk and promote the social, emotional, and developmental well-being of children; and

**WHEREAS**, effective child abuse prevention activities succeed because of the meaningful connections and partnerships created between child welfare, education, health, community- and faith-based organizations, businesses, and law enforcement agencies; and

**WHEREAS**, 10,920 CASA volunteers spoke up for the best interest of 28,543 children in Texas last year; and

**WHEREAS**, communities must make every effort to promote programs and activities that benefit children and their families; and

**WHEREAS**, Llano County is fortunate to have the caring members of the Llano County Child Welfare board who work toward improving the quality of lives of victims of child abuse; and

**WHEREAS**, we acknowledge that we must work together as a community to increase awareness about child abuse and contribute to promote the social and emotional well-being of children and families in a safe, stable, nurturing environment; and


**WHEREAS**, prevention remains the best defense for children and families; and

**WHEREAS**, Llano County Child Welfare Board, Child Protective Services, Child Advocacy Centers, foster parents, teachers and others work to ensure that children in our community have a safe, happy future; and
