Reason for Inquiry

Commissioners Court Agenda Item 7 - Ten Commandments Monument June 8, 2026 I am unable to attend tomorrow's meeting in person, so I am submitting these comments in writing for the record. FYI - there is no email address on the Llano County Website for any Commissioner nor Judge so I will try to use the "contact" form on that website for Judge Hardy and Commissioner Richards. Re: Commissioners Court Agenda Item 7 - Ten Commandments Monument June 8, 2026 I respect the role that faith plays in many people's lives, and I know many in our community hold deep religious convictions, AND our courthouse belongs to every citizen of Llano County - people of every faith and of none. I ask you a simple question: Before this was brought to your attention, how many of you were thinking "We NEED a Ten Commandments monument on our courthouse lawn"? My guess is none of you. This did not come from our community - it came from outside it. We are being used as a proving ground for a coordinated national campaign, and we deserve to recognize that for what it is. Look closely at the organization behind this donation. The American History & Heritage Foundation describes its mission as "educating the public about American history and heritage". And yet Llano County appears on their website as an "active project" for building and installing Ten Commandments monuments. Look for yourself: (<https://www.americanhistoryandheritage.org/>) That's not history education - that's a religious placement campaign with an agenda. The fact that it costs us nothing to install does not mean it will cost us nothing. This county has shown it is willing to stand on principle when it matters - that resolve is something many of us respect. That same principled thinking should apply here. Don't let "free" be the reason Llano County signs on to someone else's agenda. A courthouse stands for equal justice, blind to who you are, where you came from, and what you believe. Courts are meant to judge the facts, not the person. I'll close with Thomas Jefferson, whose 1802 letter to the Danbury Baptists remains one of the clearest statements on this question. He described the First Amendment as building "a wall of separation between church and state." That wall protects everyone, including people of faith, from a government that picks religious winners and losers. Don't let Llano County be someone else's proof of concept. I urge you to vote no. P.S. Your "Reason for Inquiry" field is a single-line format, which makes it impossible to include formatting..
