I purchased my house at 172 Chesterfield Dr. in Kingsland, Texas in 2016. At that time Llano County regularly maintained Ridgemont Dr., by grading it 3 to 4 times a year. This maintenance kept the road in decent condition and helped with proper drainage. However, for the past 4 to 5 years, Llano County has ceased to maintain Ridgemont Dr., which has resulted in significant drainage issues. The road condition has deteriorated, affecting not only me but all the residents who utilize Ridgemont Dr. as part of their daily commute. Without regular upkeep, the road has become increasingly difficult to navigate, especially during adverse weather conditions when mud and puddles accumulate and water rushes through some of the properties on Chesterfield Dr.

There are currently 8 residences, 1 business and 9 lots bought by residence living on Chesterfield Dr. with buildings, carports, or other uses on Ridgemont Drive. New utilities are being added, wells drilled, and at least one new home will be constructed this year. Maintaining Ridgemont Dr. is a crucial step that would significantly enhance the quality of life and safety for all residents in the area.

Maintaining Ridgemont Dr. will ensure proper drainage, reduce maintenance cost overall, and provide a safer and more reliable route for everyone. It is vital that we urge the local authorities to prioritize the maintenance of Ridgemont Dr. This not only addresses the immediate concern of road safety and drainage but also boost the overall infrastructure of our community. I encouraged my fellow residence of Kingsland to join me in advocating for this necessary change.
